- within the statutory liability corridor pursuant to § 449 (2) No. 1 HGB (German Commercial Code) to up to 40 special drawing rights (SDR) per kg of the gross weight of the consignment.

The insurance benefit is limited in particular as follows:

- for damage to goods and consequential damage to goods per claim EUR 600.000
- per loss event EUR 1.200.000

There is no insurance exclusion or sublimit in case, the damage was caused by gross negligence.

The insurance contract fulfills the minimum requirements of § 7 a of the German Road Haulage Act (GüKG).

On the basis of this confirmation, neither the insurer(s) nor ATRALOsecur GmbH assume(s) an obligation towards third parties. In particular, this confirmation obliges neither the insurer(s) nor ATRALOsecur GmbH to inform of any changes or terminations of the insurance cover.
